GMAT/GRE Waiver Policy

UNC Kenan-Flagler requires a GMAT or GRE score report for applicants with fewer than five years of professional experience. However, a waiver may be considered for candidates whose academic records and professional work experience demonstrate a high level of quantitative and analytical skill. Applicants who have five or more years of professional full-time work experience are exempt from the GMAT/GRE requirement and do not need to complete a waiver.

Please note: Our Full-Time MBA, Online MBA and Executive MBA programs have individual waiver request processes and requirements. You should complete this form only if you are interested in applying to our Online MBA program. If you are interested in applying to our Full-time MBA or Evening, Charlotte, or Weekend Executive MBA programs, you can access the waiver request within the application for those programs.

Waiver Form Instructions

- 1. Start an <u>MBA@UNC application</u>. Note that while you must complete the specific steps outlined below, you do not have to complete the entire MBA@UNC application to be considered for a GMAT/GRE Waiver. In the MBA@UNC application:
 - Complete the "Academic Background" section and enter information for all colleges/universities you have attended.
 - In the "Uploads" section, attach scanned copies of official or unofficial transcripts from all colleges and universities you have attended, even if you did not receive a degree. This also includes transcripts for college-level studies taken while in high school and any study abroad program for which your home institution was not the credit grantor.
 - Upload your current resume in the "Professional Background" section.
